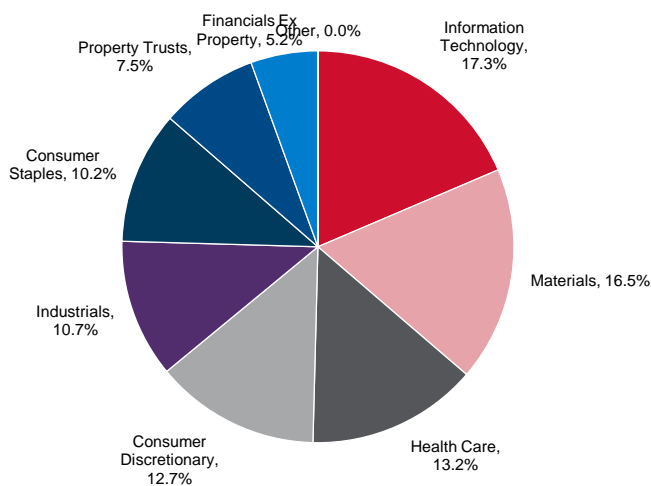

## Fund performance summary

The S&P/ASX Small Ordinaries Accumulation Index returned +10.59% for the month. The fund underperformed the market and delivered a +8.06% return over the month.

## Market overview

The S&P/ASX Small Ordinaries Index (XSO) increased by 10.6% during May 2020. The Small Industrials increased by 9.6%, while the Small Resources increased by 14.3%. XSO finished the month on a forecast price-to-earnings (P/E) ratio of 20.7x which is 31% above its 5 year average and the highest forecast P/E ratio during this period. This valuation is 18% higher than the equivalent ratio for the ASX200.

The best performing sectors were: Metals & Mining - Steel, (+26.8%), Internet Services (+20.0%), Retail (+20.0%), Metals & Mining – Precious (+19.2%) and Automotive (17.5%). The worst performing sectors during May were Energy (-0.7%), Banks (+1.5%), IT products (+2.0%) and Chemicals (+2.7%).

The best performing stocks within the XSO Index were IVE Group (IGL, +73%), Southern Cross Media (SXL, +68%), Eclix (ECX, +67%) and Zip Co (Z1P, +57%). These stocks across the board were viewed at the start of May as having significant risk from a slow recovery post the worst of the COVID-19 crisis. By the end of May they were viewed as having significant leverage to a sharper recovery.

The worst performing stocks in the XSO index were Select Harvest (SHV, -14%), Freedom Foods (FNP, -14%) and New Hope Corp (NHC, -13%). Select Harvest warned that the US almond crop was likely to be large and could put downward pressure on prices at a time when water costs rose. Freedom Foods lowered its outlook and wrote down inventory and receivables. New Hope exports coal and prices are low.

## Market outlook

The market and economic outlook is dominated by the impact of COVID-19. The economic damage measured in declines in gross domestic product and rises in unemployment is likely to be significant in a historical context. However the depth of this impact and whether the recovery is steep or slow will keep market guessing for the foreseeable future. As at the end of May 2020 the market is clearly much more optimistic than it was at the beginning of the month. We believe whatever the shape of the downturn and recovery we believe that interest rates will remain low and debt will remain very high

The ongoing trade dispute between The US and China has become more pronounced during the COVID-19 lockdown period. The US presidential election in November will probably add to these tensions.

Resources and their related mining services suppliers are also dependent on the US\$/A\$ exchange rate. The A\$ is now trading at around US0.70c which has increased from US0.65c in only a month. This increase will reduce export margins. Australia's main competitor for the sale of iron ore, Brazil, is in the midst of the COVID crisis. This is impacting Brazil's exports, boosting global prices for this commodity.
