

Fund performance summary

The S&P/ASX Small Ordinaries Accumulation Index returned +1.55% for the month. The fund outperformed the market and delivered a +3.70% return over the month.

Market overview

The S&P/ASX Small Ordinaries Index (XSO) increased by a 1.55% during February 2021. The Small Industrials increased by 1.40%, while the Small Resources increased by 2.22%. XSO finished the month on a forecast FY22 price to earnings (P/E) ratio of 21.1x which is 30% above its 5-year average. This valuation is a 13% premium to the ASX200.

The best performing sectors were: Metals & Mining – Base, (+14.2%), Metals & Mining - Other (+13.2%), Consumer Discretionary (+12.4%), Financial Services (+8.1%) and Media (6.7%). The worst performing sectors during February were Engineering & Mining Services (-10.5%), Metals & Mining - Precious (-10.1%), Banks (-7.7%) and IT Products & Services (-6.4%).

The best performing stocks within the XSO Index were Zip Co (Z1P, +52%), Starpharma (SPL, +43%), Virgin Money (VAH, +43%) and Pact (PGH, +37%). Zip announced that's its US subsidiary was growing faster than expected. Starpharma received European approval for its Viraleze nasal spray which can prevent COVID-19 from passing to the lungs via nasal passages.

The worst performing stocks in the XSO index were Service Stream (SSM, -38%), Bellevue Gold (BGL, -28%) and NRW (NWH, -26%). NWH delivered a worse than expected interim result. Bellevue Gold is exposed to a gold price that has been weak for a few months.

Market outlook

The market and economic outlook are dominated by the rate of recovery from COVID-19 and vaccine rollout rates. Currently markets are anticipating a strong recovery in industrial production in 2021. In the UK and North America, in particular, there is a race to rollout vaccines as fast as possible. Infection rates in those countries now appear to be falling rapidly. We believe whatever the shape of the downturn and recovery that interest rates will remain relatively low and debt will remain very high despite recent ructions in the global bond markets.

The ongoing trade dispute between The US and China has become more pronounced during the COVID-19 lockdown period. The election of Joe Biden as the new US President has led to a pause while markets wait to see what path the new administration in The US will take on the China trade dispute. Australia is caught up in this dispute with several exports targeted. Despite this commodity prices are rising, particularly LNG and thermal coal, key exports for Australia. Iron ore has remained strong throughout the quarter.

Resources and their related mining services suppliers are also dependent on the US\$/A\$ exchange rate. The A\$ is currently trading around US\$0.77c. The A\$ has strengthened as optimism on world growth in 2021 has improved. The farming community also looks set to significantly benefit from record crops across Australia following best in a decade growing conditions. Despite the China trade bans there seems to be



significant demand for the record Australian wheat crop and barley. Wine exports, the initial focus of China imports tariffs, have also held up much better than expected. The biggest concern at present seems to be finding enough people to pick the crops.
